**ORDER GRANTING FINAL
APPROVAL OF CLASS SETTLEMENT
AND SERVICE AWARDS**

Monarch Investment and Management Group,

This matter came before the Court on February 21, 2025, on Plaintiffs' motion under Minn. R. Civ. P. 23.05 for an order granting final approval of a class action settlement between the Plaintiffs and Defendants and approving the requested service awards. On November 25, 2024, the Court granted preliminary approval of the class settlement, appointed Epiq Global ("Epiq") as the Settlement Administrator, directed that Notice and Claim Forms be delivered to the Class by Epiq, and scheduled a Final Approval Hearing to be held on February 21, 2025. Plaintiffs filed an executed copy of the Settlement Agreement with their Motion for Preliminary Approval.

On February 14, 2025, Epiq filed a copy of the Settlement Administrator Report. This submission provided information required by the Court's Order granting preliminary approval in advance of the Final Approval Hearing, including proof of the Settlement Administrator's compliance with the Class Notice obligations of the Settlement Agreement and documentation of the results of the Class Notice Program.

Based on all the files, records, and proceedings, **IT IS HEREBY ORDERED:**

1. This Court has jurisdiction over the subject matter of this lawsuit and jurisdiction over Plaintiffs, the members of the Settlement Class, and Defendants in the above-captioned case (the “Parties”).

2. Capitalized terms not defined in this Order shall have the meaning set forth in the settlement agreement (the “Settlement Agreement”), attached as Exhibit A to the October 30, 2024 Declaration of Drew Glasnovich, are fully adopted and incorporated herein.

3. The Court now **GRANTS** Final Approval of class certification and the terms of the settlement (the “Settlement”) memorialized in the Settlement Agreement in their entirety.

4. The Court finds that for the purposes of settlement and notice, the requirements of Minn. R. Civ. P. 23.01 and 23.02(b) have been met. The Court hereby incorporates its class certification findings from the Order Granting Preliminary Approval.

5. The Court certifies the Class as: “All individuals who were tenants of MIMG on or before February 1, 2022 and (i) are or were a party to a lease agreement as a lessee at any property in the state of Minnesota at the time when MIMG owned or acquired ownership of the property, (ii) entered into a lease agreement as a lessee at any property in the state of Minnesota owned by MIMG, which lease terminated before February 1, 2022, (iii) as of February 1, 2022 were a party to a lease agreement as a lessee with MIMG in the state of Minnesota and/or (iv) were parties to a lease agreement with MIMG at Eden Park Apartments or City Limits Apartments (together Eden Park Apartments and City Limits are the “Subclass 2 Properties”) before June 1, 2024.”

6. The Court certifies two Subclasses as: the “First Utilities Subclass” constitutes any individual who qualifies as a member of the Settlement Class and who paid water and/or sewer utilities to MIMG (or to a third party acting on MIMG’s behalf) via a single meter or ratio utility billing (RUB), at any time during the Class Period. A single meter or ratio utility billing (RUB)

shall mean when a multiunit rental building with one or more separate residential living units where the utility service measured through a single meter provides service to an individual unit and to all or parts of common areas or other units.

7. The “Second Utilities Subclass” (together the First Utilities Subclass and the Second Utilities Subclass are the “Subclasses” and each subclass is a “Subclass”) constitutes any individual who (i) qualifies as a member of the Settlement Class, (ii) who was a party to a lease agreement at any of the Subclass 2 Properties with MIMG at any time up to June 1, 2024, and (iii) who paid water and/or sewer utilities to MIMG (or to a third party acting on MIMG’s behalf) via a single meter or ratio utility billing (RUB), at any time up to June 1, 2024. A single meter or ratio utility billing (RUB) shall mean when a multiunit rental building with one or more separate residential living units where the utility service measured through a single meter provides service to an individual unit and to all or parts of common areas or other units.

8. The Court further appoints, on a final basis, Plaintiffs Iris Bautista, Laura Hamersma, Sara Kolstad, Jonah Aquino, Jemicia Mitchell, Hannah Hekel, Antwan Loving, Kiona Adams, Corey Dahl, Marsha Loving, and Heavenle’ McDonald as Class Representatives and appoints, on a final basis, Stinson LLP as Class Counsel.

9. The Court finds that the Settlement is fair, reasonable, adequate, and in the best interests of the Class. The Court finds that the settlement was not a product of collusion. Rather, the Settlement Agreement was the product of an arm's-length negotiation between sophisticated counsel, aided by an experienced mediator, and made at a stage of the litigation that allowed counsel to act intelligently about the benefits and risks of continuing litigation.

10. The Parties are directed to implement and consummate the Settlement Agreement according to its terms and conditions.

11. The Settlement Administrator may distribute the class and subclass payments as set forth in the Settlement Agreement.

12. Upon the Release Effective Date of the Settlement Agreement, the Class Releasing Parties by operation of this final judgment shall be fully bound by the release terms and provisions set forth in the Settlement Agreement, and have fully, finally, and forever released, relinquished and discharged the Defendant Released Parties of and from any and all Released Class Claims that any of the Class Releasing Parties personally have or may have against the Released Parties arising out of or relating to any of the acts, omissions, or other conduct that was alleged in the Litigation.

13. Upon Release Effective Date, HOME Line by operation of this final judgment shall be fully bound by the release terms and provisions set forth in the Settlement Agreement, and has fully, finally, and forever released, relinquished and discharged the Defendant Released Parties of and from any and all claims that HOME Line has or may have against the Released Parties arising out of or relating to any of the acts, omissions, or other conduct that was alleged in the Litigation.

14. Upon the Release Effective Date of the Settlement Agreement, the Defendants by operation of this final judgment shall be fully bound by the release terms and provisions set forth in the Settlement Agreement, and have fully, finally, and forever released, relinquished and discharged the Plaintiffs of and from any and all Released Claims that any of the Defendants has or may have against the Plaintiffs, or any of them, arising out of or relating to any of the acts, omissions, or other conduct that was alleged in the Litigation.

15. The Court finds that the Class Notice Program, in accordance with the Preliminary Approval Order: (i) constituted the best practicable notice; (ii) was reasonably calculated, under the circumstances, to apprise the Class of the pendency of the tenant class action and of their right to submit a claim for or object to the proposed Settlement, and fully and accurately informed Class

Members of all material elements of the Settlement; (iii) constituted reasonable, due, adequate, and sufficient notice to all persons entitled to receive notice; and (iv) met all requirements of applicable law. The Court further finds that the Settlement Administrator has fulfilled the requirements of the Class Notice program as required by the Court.

16. The Court orders that all Class Members are bound by all proceedings, orders, and judgments of the Court, and the terms of the Settlement, including but not limited to the release provisions contained therein, regardless of any individual Class Member's response or lack of response to the Class Notice.

17. The Court orders that any Class Member who did not file a timely written objection to the Settlement or who fails to otherwise strictly comply with the applicable requirements will be foreclosed from seeking any adjudication or review of this Settlement by appeal or otherwise.

18. No Settlement Class Members have objected to any of the terms of the Settlement Agreement.

19. Epiq is administering the Settlement as the Settlement Administrator pursuant to the terms of the Settlement Agreement. Epiq shall make a settlement payment to each Participating Class Member in accordance with the provisions of the Settlement Agreement.

20. The Court approves Class Representative Awards in the amount of \$7,500 each to the Class Representatives, Iris Bautista, Laura Hamersma, Sara Kolstad, Jonah Aquino, Jemicia Mitchell, Hannah Hekel, Antwan Loving, Kiona Adams, Corey Dahl, Marsha Loving, and Heavenle' McDonald. The Court finds such amounts to be reasonable in light of the services performed by the Class Representatives for the Class Members, including taking on the risks of litigation and helping achieve the results to be made available to the Class. These amounts shall be paid in accordance with the terms of the Settlement Agreement.

21. Neither this Final Approval Order, nor the Settlement Agreement, nor the payment of any consideration in connection with the Settlement shall be construed or used as an admission or concession by or against any Defendants or any of the other Released Parties of any fault, omission, liability, or wrongdoing, or of the validity of any of the Released Claims as set forth in the Settlement Agreement. This Final Approval Order is not a finding of the validity or invalidity of any claims in this Action or a determination of any wrongdoing by Defendants or any of the other Released Parties. The Final Approval Order approving the Settlement does not constitute any position, opinion, or determination of this Court, one way or another, as to the merits of the claims or defenses of Plaintiffs, Class Members, or Defendants.

22. **IT IS FURTHER ORDERED**, effective on the earlier of (i) sixty (60) days following entry of this Order or (ii) upon entry of an order on any application(s) for attorneys' fees pursuant to the Settlement Agreement, that this case is dismissed in its entirety with prejudice, without awarding costs or fees to the Parties except as provided in the Settlement Agreement and in connection with Plaintiffs' separate application for Attorneys' Fees under the Settlement Agreement.

23. **IT IS FURTHER ORDERED** that the Settlement Agreement, including the settlement and releases contained therein, is incorporated into this Order and the terms of the Settlement Agreement are material terms of this Order.

24. **IT IS FURTHER ORDERED** the Defendants shall implement and uphold their promises to reform their lease(s) as contained in Section 7 of the Settlement Agreement, provide neutral rental references as contained in Section 9 of the Settlement Agreement, reform the collection their collection and leasing practices as contained in Section 10 of the Settlement Agreement, update their credit reporting practices as contained in Section 11 of the Settlement

Agreement, and perform all such other promises, reforms, and agreements as set forth in the Settlement Agreement.

25. **IT IS FURTHER ORDERED** that the injunctions contained in the Court's Order Enforcing Settlement Agreement, entered on November 1, 2022, and in the subsequent judgment entered on November 8, 2022 shall terminate on the Release Effective Date.

26. The Court adjudges that the Parties and Class Members have conclusively compromised, settled, dismissed, and released any and all claims released by the Settlement Agreement.

27. The Court finds the Settlement Agreement and this Final Approval Order to be binding on and have *res judicata* and preclusive effect in all pending and future lawsuits or other proceedings encompassed by the releases provided by or on behalf of the Parties and Class Members.

28. The Settlement Agreement provides that any eviction actions filed by Defendants on the basis of the eviction, leasing, collection, property management, or other similar practices identified by Plaintiffs in the Second Amended Complaint should be expunged.

29. The parties have identified a non-exhaustive list of cases (the "Expunged Matters") which they agree should be expunged pursuant to the Settlement Agreement. The list of Expunged Matters is attached as **Exhibit A** and incorporated into this Order.

30. The Court, having weighed the harms caused to the respective Class Members by the continued public record of these evictions against the benefit to the public in knowing of these evictions, especially in light of the settlements reach by the parties related to the eviction, leasing, collection, property management, and other similar practices identified by Plaintiffs in the Second Amended Complaint, and the Court having assessed the burden on Minnesota's court system in


implementing the requested relief, orders that the interests of justice weigh in favor of expunging the Expunged Matters and against keeping the cases available to the public, and the burden on the courts is not outweighed by the injustice perpetuated by leaving these cases public.

31. **IT IS FURTHER ORDERED** that the court administrator in the judicial district where each Expunged Matter has been filed shall expunge the Expunged Matters by removing evidence of the court file's existence from the publically accessible records, and for any case involving a Class Member that is not identified as an Expunged Matter, nothing in this Order precludes, estoppes, or otherwise prevents a Class Member from seeking to expunge an evictions or collections case filed by the Defendants (or any of them) in the judicial district(s) where such case was filed, and the Class Member may rely on the Settlement Agreement, this Order, and the findings herein to support the Class Member's request for expungement.

32. **IT IS FURTHER ORDERED** the Court finds that there is no reason for delay in entering this Final Order and Judgment. This Court shall retain jurisdiction solely for the purpose of enforcing the terms of the Settlement Agreement.
